ORDER BY CIRCULATION

The present RA No.74 of 2004 has been filed by the applicants for review of the order passed in OA No.205 of 2003 on 27.11.2003.

2. By filing the present RA, the applicants want to re-argue the whole case again by filing the RA, which is not permissible. While delivering the judgment, the review applicants were duly heard because the judgment was given after hearing the parties as such the RA has no merits. The applicants have also filed an application seeking condonation of delay, which is not permissible. No error apparent on the face of record has been pointed out which may call for review of the order. Further, the RA does not come within the ambit of Order 47 Rule 1 CPC read with Rule 22 (3) (f) (i) of the Administrative Tribunals Act.

3. In view of the above, nothing survives in the RA, which is accordingly dismissed. MA No.505/2004 is also rejected.
