Hon'ble Shri V.K. Majotra, Vice Chairman (A):


Learned counsel heard.

2. Learned counsel of applicants has drawn our attention to orders dated 28.1.2005 passed by the respondents. He found fault with these orders inasmuch as they have not been passed by the Engineer-in-Chief as directed by the Tribunal as also that these are not reasoned and speaking orders.

3. We have perused the orders carefully and we agree with the contentions of the learned counsel of applicants. The Engineer-in-Chief is directed to pass fresh detailed and speaking orders in compliance of Tribunal's directions contained in order dated 30.9.2003 in OA-2397/2003. The Engineer-in-Chief is also directed to pass these orders expeditiously and preferably within four weeks' time from today. In case this time, Tribunal's directions are not complied with in the true spirit, a very serious view would be taken.

4. The Contempt Petition is dropped and notices to the respondents are discharged. However, applicants shall have liberty to revive the same on remaining aggrieved.
