ORDER (ORAL)

HON'BLE DR K.B.SURESH, MEMBER (J)

1. Heard the matter in great detail. It appears to us that the methodology of King Solomon to be adopted in this case. Therefore, we will direct one more remedical examination with the concerned private Doctor also included in the panel. Let him also sit in when the remedical examination is being conducted and give his opinion in writing. The Committee will jointly consider that opinion also, if he comes. Otherwise also if the Committee passes an opinion it will be binding on both the parties. No further remedical examination will be allowed. OA is disposed as above. No order as to costs.

2. MA.520/2018 is allowed. Delay condoned. Let the reexamination be conducted within the next 2 months. Between one month and next 2 months a date shall be fixed for the examination and the private Doctor informed. It shall be the duty of the applicant to produce the private Doctor, if he wants. OA disposed as above. No order as to costs.
