Sri Harikumar G.Nair, learned counsel for the applicants submitted that the training of the applicants, which has been taken up as relief Nos. 1& 2, has since been completed and they are now eligible for promotion. The only prayer now left in the OA is for restraining the respondents from promoting the party respondents 5 to 13 as Loco Pilot Passengers, overlooking the seniority of the applicants.

2. Sri S.Radhakrishnan, Standing Counsel of the Railways, submits that the promotions are held up on account of the pendency of the OA. He now undertakes that promotions, when ordered, will be strictly in compliance with the Post Based Roster and in the case of general category candidates, based on Seniority cum Fitness.

3. Recording the submission, OA stands disposed of.
