ORAL ORDER

Neither the applicants nor their counsel in both the matters appeared today. However, Smt. K. Varalakshmi represented Smt. P. Yasasvi, learned Standing Counsel for BSNL.

2. On 15.07.2019 when the matter was taken up, learned counsel for the applicants was not present and this Tribunal has noted as under:

34. We make it clear that on the next date of hearing, if the applicants do not take steps for representing the case, then it will be presumed that they are no more interested to pursue the matter and the O.A. will be dismissed on the ground of non-prosecution.ö

3. Today, proxy counsel for the respondents submitted that the department has already regularised the services of the applicants as Junior Telecom Officers w.e.f. 2014 and in view of that matter, the O.A.s have become infructuous.

4. By the submissions made by the learned counsel for the respondents, as the applicants have already been granted relief, nothing remains. Accordingly, the O.As are disposed of as infructuous. The communication dated 04.04.2018 with due signatures of the learned counsel for the respondents is kept on record. There shall be no order as to costs.
