**COMMON ORAL ORDER**  
**Per : R.Vijaykumar, Member (A)**

These applications have been filed under Section 19 of the Administrative Tribunals Act, 1985 seeking the following reliefs in **OA No.748/2014 :-**

“a. To allow the application.

b. This Hon'ble Tribunal be pleased to quash and set aside the impugned orders dated 18.09.2014 and 08.10.2014 wherein the Respondents denied Applicants to appear for the LDCE.

c. This Hon'ble Tribunal be please to direct the Respondents to allow the Applicants to appear for the LDCE examination to be held from 20.12.2014 to 23.12.2014 and direct Respondent No.4 to issue the Admit Cards for appearing LDCE to be conducted by Respondent No.4.

d. This Hon'ble Tribunal be pleased to direct the Respondents to consider the Applicants for promotion to the Grade of Chargeman (T) if they qualify in the LDCE examination 2014-15 conducted for the purpose with all consequential benefits.

e. This Hon'ble Tribunal be pleased to grant ad-interim relief in terms of prayer clause (c) supra.

f. Any other or further orders may be granted in the interest of justice.

g. Cost of the application be awarded in favour of the Applicants.”

2. The applicants in these OAs except in respect of OA No.779/2014 have obtained

diplomas in Mechanical Engineering from the Maharashtra State Board of Technical Education, GPDL, Government Polytechnic Distance Education Learning whereas the applicants in OA No.779/2014 obtained their degree on correspondence basis from Karnataka Open University. The applicants in OA No.779/2014 had withdrawn their earlier amendment in the OA seeking to challenge the Recruitment Rules in SRO-56 which required the course to be recognized by the AICTE and in the circumstances caused by such withdrawal, reliefs claimed by all the parties have become identical. Therefore, with the consent of the learned counsels for the parties, considering that the applicants have applied for LDCE based promotion by virtue of their experience as Mechanical Engineer and similarly claimed qualifications, a common order is passed in respect of all the cases.

3. At the outset, the learned counsel

for AICTE Shri A. A. Joshi, from the instructions from AICTE submits that, by way of email, that AICTE have conveyed that they have granted approval for diploma courses conducted by MSBTE/GPDL for conduct of part-time course and grant of diploma for the period up to year 2013. Such approval does not extend to correspondence courses and distance learning courses by which certain institutions admitted and granted such diploma certificates.

4. The learned counsels for the applicants Shri P. J. Prasadrao argued in respect of all the cases other than in OA No.779/2014. He submits that the applicants have obtained diplomas specified conditions satisfied by the AICTE and which have been brought to notice by the learned counsel as set out in the previous paragraphs. Further, it is quite clear that such a clarification of the AICTE does not extend to correspondence and distance learning courses

and in this context, the applicant in OA No.779/2014 who had obtained a diploma from the Karnataka State Open University by distance learning, falls into the unapproved category in terms of the orders passed in the past by the AICTE and are, therefore, not eligible.

5. In these circumstances, these OA Nos.748/2014, 763/2016, 764/2016, 771/2016, 786/206 and 595/2015 are allowed to the extent that the applicants shall submit the necessary certificates to the respondents no.2-4 in support of their claims that they have obtained diploma by a 04 year part-time course after enrollment in the specified period and if the same is found to be correct, the respondents shall treat them as having the requisite qualifications keeping in view the aforesaid statements/clarification from the AICTE and finalize the selection of the applicant accordingly, within eight weeks.

6. In regard to OA No.779/2014, the learned counsel for the applicant has relied upon a gazette notification dated 10.06.2015 which provides that degrees and diploma awarded through distance learning mode of education awarded by an institution approved by State Legislature and Execution deemed to be authorities shall automatically be covered for employment under the Central Government provided they are approved by the UCG. On the aspect of requirement of the Recruitment Rules with courses would have to be followed, AICTE which refers to a minute dated 03.08.2017 of all the Indian Council for Technical Education in its 52<sup>th</sup> meeting at item no.52/01/05, that for recognition of professional courses after 31.05.2013, the matter would be investigated by a Committee while for institutions prior to that date the orders already issued would be applicable. The case of these applicants fall into this category of courses that have

not been recognized from the AICTE and therefore the applicants in this OA cannot be considered to be to have satisfactory requirements of the Recruitment Rules.

7. In view of the above, the OA No.779/2014 lacks merits and is accordingly dismissed.

8. There shall be no order as to costs.
