**ORDER (ORAL)**

**Jayesh V. Bhairavia, Member (Judl.) :-** M.A. 409/2019 has been filed for filing the joint application. The same is allowed. Accordingly, M.A. stands disposed of.

2. In the instant O.A. the l/c for applicant submitted that the applicants in this O.A. are working with the Central Institute of Psychiatric/Psychologist at Kanke, Ranch and has prayed for issuance of direction to the respondents for granting them Grade Pay of Rs. 4600/- in PH-2 as per 6<sup>th</sup> CPC and corresponding to Level of the Pay Matrix Rs.44,900/- as per 7<sup>th</sup> CPC putting them into the grade pay of Rs.4600/- PB-II as per 6<sup>th</sup> CPC (Level-VI) of the pay matrix i.e Rs.44900/- as per 7<sup>th</sup> CPC. It has been further submitted that vide letter dated 20<sup>th</sup> May 2019, the Director, Central Institute of Psychiatry, Ranchi (Jharkhand) as again addressed a letter to the Director General of Health Services and requested to look into the matter with respect to the claim of applicant in regard to pay fixation as per 6<sup>th</sup> and 7<sup>th</sup> CPC.

3. The l/c for respondents submits that if any application/representation of the applicant is pending or a fresh application is filed in regard to their claim, the same will consider the same as per their eligibility and in terms of 6 CPC and 7<sup>th</sup> CPC.

4. In view of the above, we dispose of this O.A. with liberty to applicant to file a fresh application with regard to their claim through proper channel.

Respondents are directed to decided the claim of applicant within 60 days from the date of receipt of copy of order and application.

5. Accordingly, the O.A. is disposed of. No costs.
