### **O R D E R (ORAL)**

**Justice L. Narasimha Reddy, Chairman:-**

The 1<sup>st</sup> Respondent initiated steps for selection/appointment of Teachers of different categories and entrusted the matter to the 2<sup>nd</sup> Respondent i.e. Delhi Subordinate Services Selection Board (DSSSB). Advertisement No. 02/17, dated 07.08.2017 was issued. The applicants responded to the same for different posts. Since large number of candidates appeared, the examination was conducted in 04 phases i.e. on 30<sup>th</sup>

September, 2018 and 13<sup>th</sup>, 14<sup>th</sup> and 28<sup>th</sup>, October, 2018.

The applicants contends that there was repetition of some questions in the examination conducted at phases 02, 03 and 04 and without taking the same into account, the results were declared. By stating these and some other reasons, they prayed for cancellation of those examinations and for conducting them in accordance with law.

2. Respondents filed counter affidavit opposing the OA. The various contentions of the applicants as regards the repetition of the questions are denied and it is stated that the selection have already been made.

3. We heard Mr. Naresh Kaushik, learned counsel for the applicants and Mr. Amit Anand, learned counsel for the respondents.

4. In respect of the very examination referred to above, OA No. 612/2019 was filed. The grievance there was that 2<sup>nd</sup> Respondent issued notice dated 01.02.2019 stating that the certain question from each of the phases are deleted and that the same is contrary to law.

5. The OA was disposed of on merits on 14.10.2019. The notice dated 01.02.2019 was set aside. It was left open to the respondents to evolve a mechanism which is objective,



lawful and logical, and then to declare the results of the candidates.

6. The subject matter of this OA is substantially covered in the Order in OA No. 612/2019. Though the nature of relief claimed is somewhat different, once the notice 01.02.2019 was set aside and an objective, lawful and logical exercise was required to be undertaken by the respondents, the relief claimed by the applicant stands covered by it. Another development is that a Writ Petition is said to have been filed before the Hon'ble High Court and the entire matter is pending adjudication.

7. Therefore, we dispose of the OA, leaving it open to the applicants to urge all the grounds, in case it becomes permissible for the respondents to undertake the exercise as indicated in OA No. 612/2019. MAs, if any, stands disposed of. There shall be no order as to costs.
