2. The prayer in the O.A. is too vague, inconsistent and in a way incompatible also. It does not reflect the actual grievance of the applicants.

3. At this stage, the learned counsel for the applicants seeks permission to withdraw the O.A., without prejudice to the rights of the applicants to pursue the remedies, in accordance with law.

4. Permission accorded. The O.A. is dismissed as withdrawn, leaving it open to the applicants to pursue their remedies, in accordance with law. There shall be no order as to costs.
