MA No. 4300/2015 has been filed by the applicants in OA No. 4618/2015 seeking permission to file the OA jointly. For the reasons given in the MA and keeping in view the no objection from the learned counsel for the respondents, MA is allowed.

Heard learned counsels for the parties. The aforesaid OAs were clubbed together by this Tribunal vide order dated 22.12.2016 by disposing of MA No. 3774/2016 in OA No. 4618/2015.

2. At the outset, Mr U Srivasatava, learned counsel for the respondents in OA No. 3404/2015 submits that he has been instructed by the respondents to bring on record the letter dated 26.11.2019 addressed to him by the competent authority i.e. The Deputy Director (Administration), in the office of the Medical Superintendent, Safdarjung Hospital & V.M.C.C, New

Delhi, the respondent in the aforesaid OA. The relevant portion of the aforesaid letter dated 26.11.2019 reads as under:-

“I am directed to refer to above cited subject and to say that the above said OAs have been clubbe by Hon’ble CAT (PB) vide its order dated 22.12.2016 in MA No. 3774/2016. It is also submitted that in pursuance of Department of Expenditure, Ministry of Finance OM No. 8-23/2017-E.III(A) dated 28th September, 2018 and Ministry of Health & Family Welfare OM No. Z.28015/05/2016-N(Pt.4) dated 09.10.2018 regarding grant of entry pay of Nursing officers, whose pay was fixed under Rule 7 of CCS (Rules) 2008, happens to be lower than the entry pay of directly recruited Nursing officer on or after 01.01.2006, this office has revised the pay of affected applicants in the above said OAs w.e.f. 01.01.2006 i.e. 12540/- +4600/- vide this office order No. 3-2/2016-Admn.III(N) dated 04.04.2019, 30.05.2019 & 25.06.2019. The details of the applicants whose pay has been revised are listed below:-

In view of the above, you are requested to apprise the Hon'ble CAT (PB), New Delhi with the above said facts of filing an MA. The next date of hearing of the case is fixed on 22.11.2019.

This issues with the approval of Medical Superintendent. ”

2. On perusal of the aforesaid letter, it appears that during the pendency of the OA, respondents have considered the claim of the applicants in the aforesaid OAs and the benefits as noted in the aforesaid letter dated 26.11.2019, have been accorded to the various applicants in the aforesaid OAs.

3. However, it is not indicated by the learned counsel for parties as to whether the claim of the remaining applicants in the aforesaid OAs have been considered and any order has been passed or not by the respondents.

In the aforesaid background, with consent of the parties, all the OAs are disposed of with directions that respondents shall pass necessary orders in accordance with the relevant rules and instructions and keeping in view the entitlement of the remaining applicants' eligibility for the relief sought or the reliefs granted to other applicants and pass a reasoned and speaking order within 8 weeks of receipt of a certified copy of the order.

It is further made clear that in case the remaining applicants are aggrieved by the order so passed by the respondents, they shall be at liberty to agitate their grievance in accordance with law in appropriate proceedings. All the OAs are disposed of in the aforesaid terms.
