### **ORDER (ORAL)**

This OA was filed seeking PCA/HPCA. Now, the applicant has produced Ministry of Health and Family Welfare, Office Memorandum No.Z.28015/119/2012-H dated 18.09.2019 and Kalawati Saran Children's Hospital, Corrigendum No.KSCH/Admn/001/HPCA/PCA/2019-20/4610 dated 24.09.2019 by which PCA/HPCA has been sanctioned to certain category of posts. It has been contended by the learned counsel for the applicant that three of the applicants No.11, 12 & 13 have been excluded from the eligible categories for which they are seeking appropriate remedy. Substantial relief having been granted, this OA has become infructuous and dismissed accordingly.
