### **ORDER (ORAL)**

**Mr. S.N. Terdal :**

Heard Mr. Yogesh Sharma, learned counsel for applicants and Mr. A.K. Srivastava, learned counsel for respondents.

2. This OA has been filed by the applicants seeking the following reliefs :

“(i) That the Hon’ble Tribunal may graciously be pleased to pass an order of quashing the impugned order dated 16.12.2014 (Annex. A/1) and order dated 7.2.2015 (Annex. A/2) declaring to the effect that the same are illegal and arbitrary and consequently pass an order directing the respondents not to treat granting of revised pay scale of Rs. 3050-4590/- as promotion for the purpose of grating the financial upgradation under MACP scheme and consequently pass an order directing the respondents to consider the cases of

the applicants for granting 3<sup>rd</sup> financial upgradation Grade pay of Rs. 4200/- from due date under MACP scheme with all consequential benefits including the arrears of pay and allowances from due date.

- (ii) Any other relief which the Hon'ble Tribunal deem fit and proper may also be granted to the applicants along with the costs of litigation."

3. From the perusal of impugned orders dated 16.12.2014 and 07.02.2015, it is clear that the respondents have not considered the recommendations of the 5<sup>th</sup> CPC regarding applicants who have got Matriculation with ITI pass as desired qualification. In view of the same, the impugned orders are quashed and OA is disposed of with the liberty to the applicants to submit a comprehensive representation to the respondents within 15 days from the date of receipt of certified copy of this order and within two months thereafter, the respondents are directed to dispose of the representation of the applicants by passing a reasoned and speaking order taking into consideration all the relevant recommendations of 5<sup>th</sup> CPC regarding the applicants with all the consequential benefits.

4. In view of above, all the pending MAs are disposed of .

5. There shall be no order as to costs.
